This letter confirms that you are covered by a Roundtrip Choice (AOS) plan. It includes benefits for Accident & Sickness Medical Expense, Emergency Medical Evacuation, Medical Repatriation and Return of Remains. The plan provides worldwide coverage (including all Schengen Countries).

COVID-19 is treated the same as any other sickness for purposes of all coverages that are triggered by a sickness or that can reimburse losses resulting from a sickness, including death caused by sickness. This includes, but is not necessarily limited to, Trip Cancellation, Trip Interruption, Accident and Sickness Medical Expense and Emergency Medical Evacuation/ Medical Repatriation/ Return of Remains (including the sub-benefits of many of these).
